

I love Emanuel's guides, he really boils these subjects down to their essential elements. 5 stars for content. The one gripe I have is with the kindle edition, the flowcharts that are a selling point for the Crunchtime books, are almost useless as they are seemingly stuck in a certain size font as to be almost illegible. At least I could not figure out a way to properly format.

This is such a great quick supplement to help me with my Tort's outline. I would not recommend using this as your ONLY supplement as I do fine the crunch time versions of the emanuel outlines skip over some parts of the course that your professor may have put particular emphasis on. Other than this one caveat I think its a great buy.
