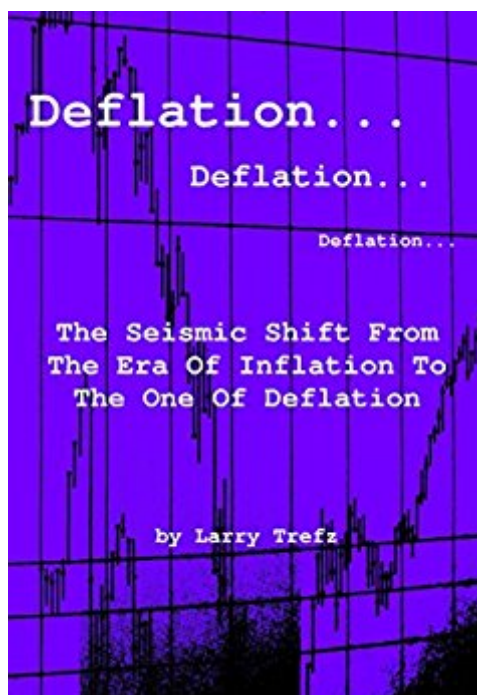

Interesting points of view. I think it is appropriate to consider that we may be in a deflationary cycle and what the ramifications of that may be as well as how to respond. While I don't think the author was completely persuasive he did have some interesting ideas and ancillary evidence. He gets a little off topic and fails to tie it together when presenting evidence that high food stamp use is evidence. There may be a multitude of other "incentives" associated with this political program. He also gets repetitive and sometimes you would swear you just read this page a few minutes ago, and some chapters don't seem to be relevant. Never the less, it is good to consider this viewpoint especially in light of economic history which contains many instances of deflation within the economic cycle.
