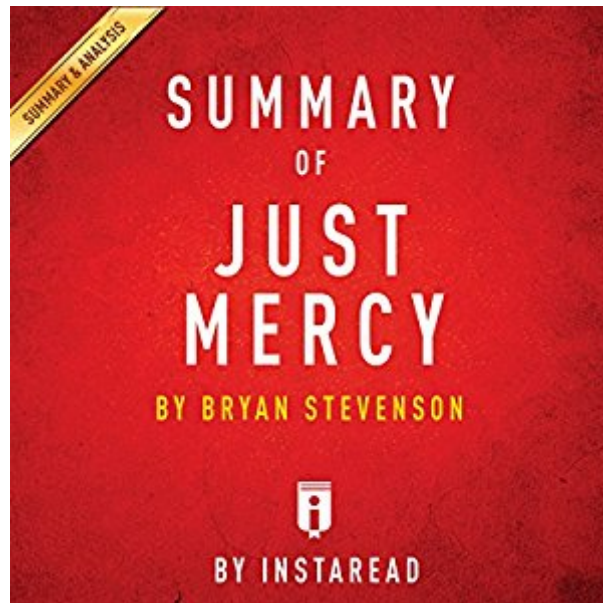

This is an overview of the actual book *Just Mercy*. Kind of like an abbreviated Cliff's Notes for the full book. It provides a potential reader enough information regarding this book's content to determine if we want to invest the extra money and time to actually buy and read the entire book. There are few circumstances that could be more

personally harrowing than to be in prison and/or on death row for a crime you did not commit. The author of this book is a defense attorney who goes into great detail regarding what is actually required to free someone who is falsely accused,. This summary provides more of the detail from the book.

This is an excellent summary of Bryan Stevenson's memoir about his career as a defense attorney in the criminal justice system. Stevenson has spent his career defending convicted men who were falsely accused. His memoir focuses on the case of Walter McMillan, a black man who was wrongly convicted of the murder of Ronda Morrison, a young white woman from a well-known family in Monroeville, Alabama. Monroeville, btw, was the hometown of author Harper Lee, who wrote *To Kill a Mockingbird*. This summary gives the highlights of Stevenson's struggle to investigate and appeal McMillan's case.
