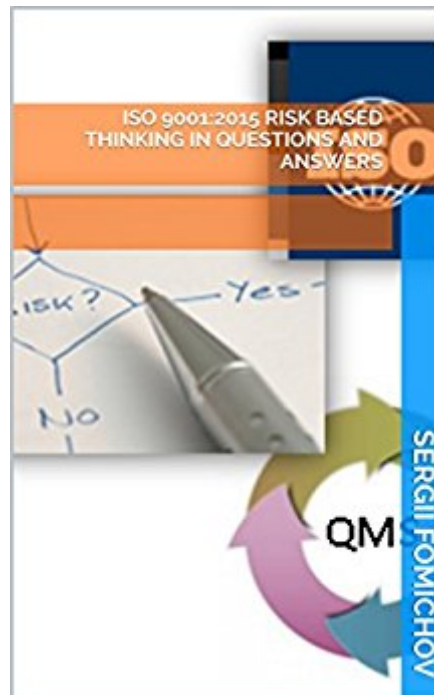

ISO 9001:2015 introduced risk based thinking as an essential part of quality management. While ISO 9001 always advocated mitigating and avoiding risk, implementing Risk based thinking is a challenge. Partially this is because ISO 9001:2015 sees the risk as both positive and negative (positive risk is referred as opportunity) and the organization is expected to address both aspects.
